- a) CCTV Project We are currently undertaking to install CCTV cameras to cover the entire Manukau BID area. ICE Security has conducted a CCTV Audit of the district and we have consequently received 3 tenders worth considering. These 3 tenders were all very different so we have contracted an independent consultant, Scott Bain of SecuroGroup to review and make recommendations on our best option. We intend to complete the installation of the CCTV network during the 2019 financial year.
